Background

This event explores the opportunities for UK companies to work with people from overseas to help overcome skills shortages and to benefit from particular overseas skills and experience. Work on nuclear and defence sites is building up at a time when the skills base is diminishing and there is strong competition for labour from the mainstream construction industry. There are likely to be skills shortages until current education and training initiatives bear fruit.

Many overseas companies already work here and UK companies are active in overseas markets. There are also potential linkages through existing business networks that could be explored. However, the challenge is working out how to use the skills in ways which are of benefit to the UK and to the other countries.
